#### Financial Report

1. Membership renewal lower year over year due to our rotating membership renewal system. This is expected to balance as the rotating renewal dates become due.
2. E-transfer system is working well.
3. At time of meeting; September books are not yet complete.
4. We are currently showing 370 members not yet renewed. Again due to the newly established rotating renewal system.
5. Membership dues line down year over year; once again due rotating membership renewal.

#### President.

1. Roof on Club House has been repaired.
2. Reviewed letter from CFO.
  - a. 50 yard range not approved due to anticipated drainage issue which has already been corrected.
  - b. Ground Baffles did not meet CFO expectations. Previous design grandfathered in, however we did not have appropriate approval for the current design.
  - c. CFO indicates overhead baffle does not meet Regulatory Criteria's. This information is not accurate and will be reviewed with CFO.
  - d. Targets cited by CFO as not being within reasonable distance from berms. To be rectified.
  - e. We had previously received verbal approvals and / or agreements with CFO. This will be changed immediately. All communications to be now in writing.
